III. SUPERINTENDENT'S REPORT

A. District Highlights

Dr. Angela Dominguez, Superintendent presented on the following:

• Presented a short video on the Teacher Toolkits (Goal 1) that teachers received to start this year. Items that were distributed were in the board room so that they could see it first hand. Teachers were very appreciative. Dr. Dominguez thanked everyone involved for their support in getting this into the district and distributed to the classrooms.

B. School Safety Center Intruder Audit Report

Dr. Angela Dominguez, Superintendent stated that the top priority in Donna ISD and the State of Texas is keeping students and staff safe everyday. TEA recently conducted intruder detection audits at one or more of our campuses. The audits test to see if a campus is accessible to unauthorized individuals. The audit provides us the opportunity to create a safer environment for students and staff. It is in the best interest of students that we do not share this information to the broader public. Specific details of the intruder detection audit will be discussed in Executive Session and with our Safety and Security Committee. Donna ISD is committed to provided a safe learning environment to all students and staff.

Trustee Eloy Avila nominated Joe Olivares. Motion to approve Joe Olivares was made by Trustee Ida Garcia and seconded by Trustee Eva Castillo Watts. IV. MONITORING AND ACCOUNTABILITY (LSG)

A. LSG Progress and Accountability Presentation Goal 1-Math GPM 1.1, 1.2, 1.3 Superintendent Constraint CPM 3.1

Mr. Javier Villanueva and Mrs. Stephanie Powelson-Garza presented on Goal 1 Math, Superintendent Constraint 3.1 and Board Constraint 2.

Prior to presentation Mr. Villanueva made a "Celebration" presentation.

- 2022-2023 took 13,542 assessments 51.5% of all assessments taken met or exceeded expected growth.
- 275 teachers that administer STARR EOC from 4th –US History out of these 123 teachers had 55% or more met or exceed expectations.

Dr. Dominguez stated that they had teachers indentified in all three brackets (Recognized, Exemplary, Masters).

They covered the following:

- Reviewed the LSG Board Goal 1 Data for Math at BOY
- Reviewed reinforcements and refinements including year-to-date progress of Goal 1
- Reviewed Superindent Constraint 1 CPM 3.1

Reinforcements:

- Increased use of hands-on activities and physical manipulatives
- System in place to identify teachers in need of additional support and intervention; progress monitoring weekly for teachers
- Implementation of Goal 1: Focus on Student Success

Refinement:

- Continue to develop our instructional assistants to provide small group instruction to students in PK-2nd Grade.
- Continue to develop our district Lead teachers with monthly trainings.
- Continue to develop our district instructional leaders (campus administrators and strategists) on the "See It, Name It, Do It" Instructional Coaching model.

Aspiring Principals Cohort – training begins on Wednesday, October 11, 2023. Donna ISD is creating a "Principal Pipeline" within our district.

Motion to accept monitor level was made by Trustee Dr. Maricela Valdez and seconded by Trustee Eloy Avila. Board Vice President Fernando Castillo, Trustee Ida Garcia, Board Secretary Jose Reyna, Trustee Eloy Avila, and Board President Jose L. Valdez voted in favor. Motion carried.

Dr. Angela Dominguez, Superintendent on that Board Constraint 2 the Board will not fail to report the year end school board CEC hours on an annual basis and ensure to report September or October board meeting. Valdez reported the following: Continuing Education is the basic obligation and expectation of any board member under the State Board of Education rules.
