 - We have met all areas for board constraints and goal progress measures in that area.
 - Donna ISD Board is the highest ranking board for Lone Star Governance scores across the state of Texas
 - First Lunch and Learn was held this week at Donna North High School.
 Next Lunch and Learn sessions will be at DAEP and AP Solis Middle School
 - State Accountability Update
 - State has put a pause on release the A-F ratings and how they will reevaluate how they will be assessing schools particularly in the area of growth.
 - o Analysis of the growth data.
 - Shared Donna ISD 2023 STAAR Exam Results growth
 - o In 2021 Donna ISD was the lowest performing district at 41% passing, 2022 jumped to 63% passing in one year. Goal for 2023 is 65%
 - A legacy doesn't happen overnight.

Reinforcements:

- Increased implementation of Goal 1 strategies: gradual release model, explicit instruction (PK3-12th)
- Teacher Assistants have been receiving training consistently to support their role in the instruction
- System in place to identify teachers in need of additional support and intervention; progress monitoring every 2 weeks for studens, weekly for teachers.

Refinements:

- Continue to develop our instructional assistants to provide small group instruction to students in PK-2nd Grade
- Continue to develop our district Lead Teachers with monthly trainings with focus on observation and feedback
- Continue to develop our district instructional leaders (lead teachers, campus administration & strategists) on the district Instructional Coaching model

Superintendent Constraint CPM 1.1: The gap between current Emergent Bilinguals and the All Student Group for STAAR 3-EOC in reading and mathematics shall not exceed 15% as measured by the TEA Accountability report. The gap in STAAR Reading (Grades 3-10) is 7% and STAAR Math (Grade 3-9) is 2%. Target for 2022-2023 was 13%. The board is currently in compliance with all required deadlines as listed in statute.
