Dr. Angela Dominguez, Superintendent, presented the School Safety Center Intruder Audit Report. Top priority of Donna ISD and the State of Texas is keeping students and staff safe every day. The Texas School Safety Center recently conducted intruder detection audits at one or more of our campuses. This had been going on all year long at every school district across the state of Texas. These audits are conducted as part of Governor Abbott's school safety initiatives after the tragedy in Uvalde.
